Health Guarantee

Seller guarantees the kitten/cat to be in good health at the time of transfer. Purchaser is encouraged to have the kitten/cat examined within 48 hours after transfer. If a licensed veterinarian finds a serious life-threatening medical condition within that period, Purchaser must notify Seller immediately and provide written documentation.

Seller provides a one-year health guarantee toward HCM and lethal genetic or congenital defects. This guarantee does not cover respiratory infections, parasites, fleas, ringworm, stress-related illness, minor common conditions, injury, neglect, improper diet, or conditions caused after transfer. Seller is not responsible for veterinary bills incurred by Purchaser unless agreed in writing.

Spay / Neuter and Breeding Rights

Unless breeding rights are specifically granted in writing and paid for, the kitten/cat is sold as a pet only with no breeding rights. Purchaser agrees to spay/neuter the kitten/cat by the agreed age or as recommended by a licensed veterinarian. Proof of spay/neuter may be requested by Seller.

Treatment and Care of Cat

Under no circumstances shall this kitten/cat be declawed. Declawing is an amputation and may cause pain, behavioral issues, and litter box problems. Purchaser agrees that the kitten/cat will never be declawed.

Under no circumstances shall this kitten/cat be permitted to live outdoors. The kitten/cat must be kept as an indoor companion animal in a safe, clean, and loving environment.

Under no circumstances shall this kitten/cat be tattooed, pierced, or subjected to unnecessary fashionable body modification. Purchaser agrees to provide proper food, clean water, warmth, hygiene, enrichment, and responsible care.

Breed Considerations

Purchaser understands that hairlessness may vary between Sphynx, Elf, Bambino, Dwelf, and related hairless breeds due to hormones, climate, age, and genetics. Complete lifelong hairlessness is not guaranteed. Some kittens/cats may develop light hair on the tail, feet, face, or ears.

Purchaser understands that Sphynx and related hairless breeds require special care, including regular bathing when needed, nail and toe cleaning, ear cleaning, warm living conditions, and protection from sunburn and cold temperatures.

Relinquishment / Return to Seller

Purchaser agrees that the kitten/cat shall never be sold, surrendered, transferred, or given to a pet shop, animal shelter, research laboratory, broker, or similar facility. If Purchaser is unable to keep the kitten/cat at any time, Purchaser must contact Seller first. Seller will be given the first option to take the kitten/cat back or assist with safe rehoming.

Breach of Contract

If Purchaser violates any term of this agreement, Seller may require surrender of the kitten/cat with no refund. Purchaser may be responsible for damages, veterinary expenses, attorney fees, court costs, and other costs resulting from breach of this agreement, to the fullest extent permitted by law.
